1.0 INTRODUCTION

Agriculture remains the backbone of Tanzanian economies, providing food, employment, raw materials for industries and foregn currency. The International Agricultural Exhibition brings together National and International stakeholders to showcase technologies that are appropriate, practicable, affordable and environmentally friendly to farmers, livestock keepers and fishermen to increase productivity and profitability along value chains

In Tanzania, Nanenane Agricultural International Exhibition will be held in Dodoma from August 1st to 8th, 2025, at Nzuguni Nanenane Exhibition Grounds in Dodoma City. The inauguration will be on 1st August 2025 and ends on August 8th, 2025 the ceremonies to be graced by National High level Officials.



1.1 Historical background of Nanenane Agricultural Show

Nanenane Farmers' Day celebrated back 1960s in Lake Zone by cotton farmers through their Cooperatives Societies. In 1964, Farmers' Day was listed in the Public Holidays Act, known as Sabasaba and celebrated on July 7th of each year, which was also the anniversary of the birth of the TANU Party. The Sabasaba festival which is currently under the Tanzania Trade Development Authority (TanTrade) in the Ministry of Industry and Trade is organizing international a Trade Fair annually. Hence, the Farmers festival is celebrated on 8th of August every year and known as Nanenane. It brings together exhibitors from private sector, public institutions, academia, research institutions, policymakers, advocacy groups, and International Organization and development partners.



1.2 Nanenane International Agricultural Expo

The Nanenane International Agricultural Exhibition for the second time was held in 2024 at Nzuguni Grounds in Dodoma City 11km from Dodoma Airport. For the year 2025, Nanenane International Agricultural Exhibition will take place at the same venue at Nzuguni in Dodoma City and will go hand in hand with zonal agricultural shows country wide.

1.3 Theme for the year 2025

The theme for the 2025 Exhibition is "Leadership for Resilient Future: Advancing Sustainable Agriculture, Livestock and Fisheries 2025." This theme underscores the importance of electing leaders who are committed to transforming the agriculture sector in a sustainable way.



2.0 Objectives:

2.1 Main objective

To be a hub for providing education, knowledge and technology to farmers, Livestock keppers, fishermen and other stakeholders along the value chain.

2.2 Specific Objectives

- i. To highlight innovations in agricultural technologies and practices.
- ii. To foster international collaboration and partnerships in the agricul tural sector.
- iii.To provide a platform for tehnology transfer, knowledge sharing and discussions on food security and climate change to improve productivity.
- iv. To create a space for business development, including new product promotion, networking, and investment opportunities.

3.0 Target Audience

During 2024 Nanenane International Agricultural Exhibition, more than 700 exhibitors participated, attracting an average of 800,000 visitors in Dodoma. The 2025 Agricultural exhibition, is expected to attract over 1,000 exhibitors from various sectors, including:-

- iii. Agribusinesses, agro-tech companies, and agriculture related arti san

11. EXHIBITORS OBLIGATION

All exhibitors are notified that full payment for the space/booth must be made before the commencement of the Nanenane Agricultural Exhibition Trade Fair. Management will oversee and approve all decoration and branding to meet international standard. The costs for participation and booth hiring will be availed through Nanenane website. Subletting of booths/spaces is strictly prohibited unless stated other wise. Furthermore, showcasing materials or publications that contravene the laws and regulations of the Republic of Tanzania is strongly prohibited.

12. ELECTRIC SUPPLY

The standard electrical current used throughout the United Republic of Tanzania is 240 volts with a frequency of 50 Hz. The electric plugs and sockets are of the G type. It is recommended that participants bring their own adaptors to comply with the electric current and plugs.



13. CURRENCY AND BANKING SERVICES

Currency: The official currency of Tanzania is the Tanzanian Shilling (TZS). Currency exchange services are available at banks, airports, and bureaux de change.

Banking Services: Monday - Friday, banking service commence at 08:00 to 16:30 and 09:00 to 13:00 on Saturday. Most banks have cash dispensing machines across the city that accept Visa, MasterCard and
